- Studies, evaluates, and recommends instructional materials, teaching methods, programs, evaluations, and data monitoring methods to the district administration.

- Provides leadership in the development of the K-8 instructional program, specifically methods of teaching, for all areas of the curriculum
- Assists in the development and implementation of the school's professional development program for the instructional staff, including collaboration for network-wide professional development
- Creates and shares content area or grade level resources to assist with the delivery of instruction
- Conducts classroom observations and provides supervision/evaluation of teachers as assigned by the Director of Educational Programs and Student Support Services
- Assists in the development and coordination of the sections of the budget that pertain to overall programing and staffing, with specific emphasis on curriculum and instruction
